## **Conservancy Corner**

### **We're Smokin!**

The smoke rising from the western shores of Deer Lake about a month ago was not from Jim Miller's chain saw, but from a controlled burn conducted by the Wisconsin Department of Natural Resources on our Maple Cove conservation area. A persistent southerly breeze caused postponement of a similar burn on our Flagstad Farm property on the south western side of Deer Lake. Such burns control the growth of unwanted species on our prairie restorations and greatly increase the germination rate of the approximately fifty species of wildflowers planted in these areas. The Flagstad Farm burn will likely be delayed until this fall.

### **We're Rockin!**

Figuratively speaking of course. Actually, the Conservancy has several projects going in our Flagstad Farm conservation area. One of which is covering the rocks, actually an abandoned gravel pit. The top soil to replant this area will be provided by a major reworking of several retention ponds on the property. In addition, an abandoned well has been capped and future hiking trails are being planned. Should you wonder why we bit-off such a large piece with this project, walking it on a fine spring day should convince even the most skeptical soul that we indeed did the right thing.

### **We're Lookin!**

For members that is. Our spring membership letter will be in the mail soon. To refresh your memory, we have several levels of membership available, designed to fit virtually every Deer Lake resident. ## DNR Funds Sought for Lake Protection

Applications were recently submitted to the Wisconsin Department of Natural Resources for two projects to preserve Deer Lake water quality. The Deer Lake Improvement Association is cooperating with the Deer Lake Conservancy on both projects. Stay tuned for the results; formal grant notification will likely occur by September of this year.

The first grant application requests assistance with the purchase of the Back 20 acres of the Flagstad Farm property. This 70-acre parcel, purchased by the Deer Lake Conservancy on a land contract back in 2002, has been transformed from cornfields to prairie to reduce runoff of nutrients into Deer Lake. The Back 20 acres was excluded from a \$200,000 Lake Protection Grant last year because of uncertainty of the future Highway 8 location at the time. If successful, the grant would bring almost \$100,000 toward repayment of the property debt.

The second project addresses runoff and erosion from areas immediately surrounding the lake. As agricultural sources of runoff are addressed, reducing runoff from this direct drainage area becomes more important. The grant would provide technical assistance and funding for correcting erosion problems and reducing runoff from waterfront lots and back lots. The problems may range from small areas of erosion on a single lot to medium sized gullies created from runoff from roads and multiple lots.

## Water Quality & Ecology Committee Report

The Deer Lake Improvement Association has heard from a number of individuals and certainly concurs that water quality and water use issues are a priority. The DLIA Board has elected again to contract with Lake Management Incorporated, Wisconsin Operations, regarding aquatic nuisance management.

Filamentous algae control on areas up to 15 acres per treatment with approximately seven treatments throughout the summer of 2006 is planned. This is carried out with a DNR permit and generally the treatment days include Tuesdays or Wednesdays, at a cost of approximately \$9,000 to \$12,000 for the year.

An aquatic invasive species control grant application has been accepted and 50% match funded of \$40,000 in conjunction with Cheryl Clemens, a consultant, and the Town of St. Croix Falls. This grant will help us provide education and prevention. An aquatic plant management plan has been completed and submitted to the DNR. This includes an aquatic plant identification process throughout the year of 2006, an intern to help us with the study management considerations, and coordination of volunteers.

We continue to study curlyleaf pondweed and feel that we will be able to implement a curlyleaf pondweed management program and close monitoring to determine the effects of treatment. There will be inspections at the landings for any presence of Eurasian water milfoil along with a sign placed at the public landing to help promote education of appropriate and correct aquatic plant invasive species control.

## Hall of Fame



## Maintaining Your Septic System

You flush the toilet, and it's gone, right? Maybe not. If your septic system is not maintained properly, waste products (including potentially harmful bacteria, viruses and nutrients) may be entering your drinking water supply and the lake. Properly maintaining your septic system will help to avoid these problems.

There are two main components to a septic system — the tank and the drain field. Wastewater flows first to the septic tank where solids settle out. The liquid is discharged to a soil absorption drain field where nutrients and contaminants are partially removed. Soil cannot remove solvents, drain cleaners or other strong household chemicals.

### Hints to properly maintain your system:

#### Things to do:

- Limit the water entering your tank — use water saving fixtures, and wash clothes one load at a time.
- Pump the septic tank regularly — this means every two or three years (or annually if you use a sink garbage disposal). A septic system pumper can provide additional guidance on when to pump.
- Learn where your tank and drain field are located — divert surface water flow away from the drain field.

#### Things to avoid:

- Do not divert clean water such as from a basement sump pump to the septic tank.
- Avoid putting materials down the drain that might clog the septic tank outflow (fats, grease, coffee grounds, disposable paper products).
- Do not put toxic substances down the drain.

Your efforts to maintain your septic system will help to keep your family's drinking water safe and Deer Lake clean!

## Personal Watercraft (Jet Ski) Law: (Synopsis)

- Persons within the ages of 12-15 must be in possession of a valid boating student certificate.
- No person may operate a Personal Watercraft (PWC) from sunset to sunrise.
- PWC's are restricted to a slow-no-wake speed within 200 feet of shore on any lake in Wisconsin.
- It is illegal to operate a PWC within 100 feet of:
  - another boat
  - a water skier
  - an occupied anchored boat
