Basic Boating Rules

Safety comes first on Deer Lake, so let's be courteous of all the boaters so we can have a safe and fun time. Two easy Wisconsin boating rules to remember, the 100 Foot Rule and the 200 Foot Rule.

- **The 100 Foot Rule:** While operating a motorboat, Slow-No-Wake speed is required when within 100 feet of a raft, pier, buoyed restricted area and lake shore, and when within 100 feet of any other boat, including other PWCs.
- **The 200 Foot Rule:** While operating any (PWC) Personal Watercraft, Slow-No-Wake speed is required when within 200 feet of the shoreline.
- **Slow-No-Wake:** Moving as slow as possible while still maintaining steerage (control of boats direction).

Environmental Updates:

Volunteers Wanted for the Clean Boats, Clean Waters Program (CBCW)

The Clean Boats Clean Water program is continuing in 2022 to help educate lake users on the rules and regulations of launching boats in WI. We have hired 4 part-time interns to work the landing throughout the busy season, if you see them say a friendly hello. The DLIA runs this program, and the Wisconsin DNR covers 75% of the costs. We are also soliciting volunteers to supplement our efforts. Please consider taking on a few shifts this summer, it's a great way to give back and get your kids and grandkids volunteer hours while spending quality time together! Zebra Mussels

You may be aware that zebra mussels have been found at several locations throughout the lake. To date, they have not been found in abundance and our hope is the lake is not a particularly conducive environment for them and their numbers remain sparse. However, this may not be the case and we could see more of them in the

coming years. The DNR has stated that Deer Lake will not be able to obtain a permit for treatment since they have been found throughout the lake.

It should be noted that currently Deer Lake is the only lake in Polk county that has zebra mussels. Please make sure that you and your visitors take special care to clean, drain, dry boats and equipment when moving them to another lake. This is especially true with wake boat ballast tanks.


Aquatic Management Plan

The Deer Lake AMP will be updated in 2023. This is a plan we write and update every 5 years. It is required that we have this AMP in order to be eligible for grant money.

We will be looking for lake resident volunteers to help with the plan. It will require 6 to 8 hours of meeting time and is a great way to learn more about the lake and invasive species. If you are interested in volunteering, please contact Kate Wright at <u>wrig5807@gmail.com</u>.

Curly Leaf Pondweed

As in past years, we are treating four Curly Leaf Pondweed beds totaling 7.6 acres in May. This treatment will cost approximately \$8,150, of which half is covered by a DNR grant.

Deer Lake Shoreland


Shoreland, the area adjacent to the water, is critically important to the health of Deer Lake. As an owner of Deer Lake shoreland, you have the opportunity take action to protect and improve lake health.

Features of a Well- Vegetated Natural Shoreland

- Includes native plants, shrubs, and trees
- Provides habitat (food, shelter, and a place to bear young). Ninety percent of all lake life is born, raised, and fed in the littoral zone, the area where land and water meet. Eighty percent of plants and animals on the endangered species list in Wisconsin live all or part of their lives near the shoreline.
- Absorbs runoff which carries nutrients, sediment, and other pollutants to the lake
- Along with improvements further back in the watersheds, protects and improves water quality. High water quality results in higher property values
- Creates a peaceful, north woods setting

How to Create a Healthy Shoreline

- Allow the shoreline edge to grow or plant native plants for shoreline stabilization. Deep roots of native plants help to prevent erosion along the water's edge. Lawn grass roots are only a few inches deep, while native plant roots can extend several feet into the soil.
- Allow fallen trees to remain in the water. They provide habitat for fish and turtles.
- Minimize removal of plants in the water. Herbicide use in the water is illegal without a DNR permit.
- Create areas on your lot where water can soak in and divert water to those locations. Water can be directed to well-vegetated areas, rain gardens, and rock infiltration areas. Join the dozens of Deer Lake property owners who have completed projects on their properties!



- Minimize areas of bare soil on your lot. If you are building, seed a temporary cover of oats or annual rye until your construction project is complete. Install silt fence to minimize runoff from construction sites.
- Inspect and maintain your septic system.
- Reduce hard surfaces like paved driveways, sidewalks, and roof tops to minimize runoff to the lake.

Ask for Assistance

The Deer Lake Conservancy provides free consulting services for shoreline health improvements. Almost half of Deer Lake owners have taken advantage of these free visits! Partial funding is also available for installation of some projects with support from WI DNR grants. Boating Safety

If you haven't reviewed the boat safety rules for 2022 please take a moment and review the rules listed on the Wisconsin DNR website:<u>https://dnr.wi.gov/topic/ boat/</u>



When bored at night feel free to read "The Handbook of Wisconsin Boating Laws and Responsibilities," https://dnr.wi.gov/files/PDF/pubs/LE/LE0301.pdf

Here's a quick review of the basics:

- Always make sure you have enough life jackets on board your boat. You are also required to have at least one U.S. Coast Guard-approved Type IV throw-able PFD, either a ring buoy or seat cushion, on recreational boats that are 16 feet in length or longer.
- Observe the Slow/No Wake zones: within 100 feet of the shoreline or another boat/PWC.
- Some residents have placed buoys in Deer Lake. Any placement of informational and regulatory buoys must be approved by the local DNR Conservation Warden and by the local unit of government. To

apply for a permit to place a marker buoy, visit <u>Waterway Markers</u> for permit applications.

Paddle Boards:

- Fastest growing water sport in the world.
- Requires same safety precautions as kayaking or canoeing.
- Have a life jacket on the board for each person, preferably wearing it!
- Be a competent swimmer.
- Carry a whistle
- Know how to tow another board
- Paddling course available:

Personal Water Craft's (PWC / Jet-ski)

- Operator must wear a life jacket at all times.
- Observe slow/No Wake within 200 feet of any shoreline and 100 feet from another boat/PWC.
- Operation of PWC can only occur between sunrise and sunset.

Barking Up the Wrong Tree ... #@!\$

FYI lake residents. Beavers have been especially active this last year. Many trees have been lost that are so vital for the protection of our shoreland. Two lake owners have contacted trappers. The good news is that 6-8 beavers have been trapped near their lodge, near the boat launch ... and the trappers are still setting traps. Apparently with verification from the trappers of their bounty, the DNR can be contacted and further help in controlling the beavers could happen with the DNR's help.



You too can help. If you have any trees lost to a beaver, please consider wrapping other nearby trees with hardware cloth [heavy duty wire mesh] to slow their destruction. It all helps.

Water Ski Course

A Deer Lake resident has purchased a water ski slalom course and will be setting it up on the lake this summer. It will be set up in accordance with Wisconsin Lake Laws, including removing it by sundown. You don't have to sacrifice safety and convenience with these best practices to reduce light pollution.

 Solar lights are a great option for those needing light and help save on your energy bill. Most emit less light than electric counterparts and have shields to keep beams pointed down.

- Put your electric lights on a timer or motion sensors so that they automatically turn off at bedtime or when not being used.
- For those looking to maximize efficiency, consider installing a smart home device. Many of these devices feature the ability to turn off your lights remotely for those times when we forget to do so when heading back home!
- Avoid blue lights in the outdoors and turn off unnecessary indoor lights to reduce glare.
- Be aware of your neighbor and those that are across the lake from you when choosing your optimal lighting options.


Spread the word to your neighbors and take time to enjoy some stargazing!
